effective from 1 January 2024

- All amounts, charges and prices exclude VAT.
- Our invoices must be paid within 14 days from the date of the invoice without any postponement or settlement. If this period is exceeded the client is in default and is obliged to pay interest at the statutory rate. All (external) legal costs and expenses – which are connected with the collection of invoices and are rated at a minimum of 15% of the amount that is to be collected, with a minimum of Euro 125,00, increased by the loans – will be at the expense of the client.
- Application and support include all standard services. Non-standard services are charged only after prior consultation and/or prior given estimate of costs.
- All charges of external authorities mentioned in the scale of charges apply subject to interim changes.
- The charges of the 'World Intellectual Property Organization' are applicable in CHF. The rate of exchange used by us for these fees is 1 CHF = 1 EUR, and subject to future (exchange rate) changes.

**Extensive subscription includes** all the activities comprising the basic subscription plus monitoring and watching later, possibly conflicting trade mark applications and registrations plus drawing up and sending of first warning to infringement makers.

**Registration, Basic and Extensive subscription never include** drawing up (licence) agreements, correspondence with respect to opposition- and legal procedures, (further) correspondence other than following the activities as mentioned above, (further) fees and expenses other than following the activities as mentioned above.
